## Lee Romero

### Accidentally Shoots Self

Lee Romero, son of Albin Romero, was accidentally shot and mortally wounded Sunday morning about 8 o'clock, while engaged in cleaning a rifle, at the home of his father in Hasley Canyon west of Castaic.

After the accident Romero drove his car three miles, to the home of Roy Abbott, who brought him to the emergency hospital, Newhall, for first aid. He was later taken to the general hospital in Los Angeles where he passed Sunday evening at 8 o'clock.

Lee was 24 years of age, a capable young man, highly respected by all who knew him. He was unmarried, and lived with his father on the ranch.

The funeral was held at Santa Paula, Wednesday, where a large concourse of friends gathered to pay their last token of respect to one they had known and respected thru life.

## Water And Power Act

It is unsafe to give a board of five unnamed members power to spend five hundred million dollars (\$500,000,000) of the people's money without control or vote by the people as to WHERE or HOW it shall be spent. For instance, nearly all undeveloped sites for hydro-electric development in this state are in the northern mountains. All this money might be spent there to serve territory distant from southern and central California, and yet the people of southern and central California would be subject to heavy taxes to meet all operating deficits.

With this great sum of money at its command, and the right to employ as many persons as it might desire, at any salaries it might see fit, the board would become the controlling power of the most gigantic political machine ever created.

## Supervisors Endorse Bonds

October 29, 1924

We, the undersigned, do heartily endorse the proposed \$5,000,000 County bond issue for the elimination of railway and highway grade crossings in the County of Los Angeles, to be voted on by the electors at the election on November 4, 1924; and we urgently request your co-operation and assistance in calling this matter to the attention of the public and urging their support thereof.

The credit of the state is needed for schools, roads, institutions, public works and many other things necessary to the upbuilding and progress of the state. The issuance of \$500,000,000 in tax-exempt bonds would increase the interest rate on all other public bonds hereafter issued, thereby directly increasing the taxes of all citizens and making constructive improvements for the public welfare more difficult.

To bond the State of California for \$500,000,000 for an undertaking of this sort means that every taxpayer must assume the risk of a huge political experiment which at best would merely provide service which the people already enjoy without public debt, personal liability or tax burdens.

This act relates to power development and not to the better distribution of the waters of the state to irrigate the great valleys. The state has expended \$225,000, and is now expending an additional \$100,000 to prepare a co-ordinated plan for the better distribution of waters for irrigation. A comprehensive report will be made to the legislature next January. This act provides no co-ordinated plan either for water or power.

Nowhere in the United States is hydro-electric energy being developed on so great a scale, with such high efficiency and splendid results as in the State of California, and nowhere

is electric power so cheap as in this state.

Do not confuse the water and power act (No. 16 on the ballot) with the United States government project to develop the Colorado River and Boulder Canyon Dam. This act provides not one penny to bring water or power from the Colorado River. If carried, the water and power act would indefinitely delay and possibly defeat the Boulder Dam project and the development of the Colorado River.

The same water and power act was overwhelmingly defeated by the voters of California in 1922. It must be defeated again.

Chambers of Commerce and business organizations generally throughout the state have adopted resolutions condemning this act and urging the people, in order to safeguard and continue the prosperity and development of California, to vote against it.

There is not a vacant house in Newhall, and several families who wished to settle here have had to locate elsewhere.

**WHAT IS THE WATER AND POWER ACT?**

An initiative measure (No. 16) on the November ballot, which, if carried, will enable a board of five persons to issue five hundred million dollars - (\$500,000,000) worth of tax-exempt bonds, backed by the credit of the State of California. If this tremendous sum is not sufficient, the board may issue more bonds practically without limit.

This immense sum of money is to be spent ostensibly for the development of hydro-electric power, BUT the measure is so broadly drawn that the board may engage in any form of business it finds "CONVENIENT," or confiscate any property it may deem "NECESSARY" for its purpose.

The act provides that if the earnings on the money invested are not sufficient to provide for principal and interest payments, then the board, without consulting the legislature or the governor, may take out of the state treasury sufficient funds to make up the losses and the people must be TAXED to replace the money so taken.

The board will NOT be elected by the people, but will be appointed by the governor, and it will take two-thirds vote of all the members of the state legislature, (which meets only once in two years), to remove any of the board members from office. The governor can not remove them.

Under the act, the board may charge any rates for electric energy that it desires, without control or regulation by the people or the State

Railroad Commission. It may take away from any city, farming community or water district its undeveloped water and power resources if they are not developed within two years after notice of the board's intention so to do.

The board is all powerful, and may engage in any line of business, employ as many people as it desires, at

whatever salary it sees fit, and to quote the exact language of the act, it is authorized "To exercise ALL POWERS needful for the accomplishment of the purposes of this article, and such ADDITIONAL POWERS as may be granted by the legislature."

When police protection is needed it is needed at once. Emergencies arise quite often on the Ridge, where immediate action is necessary. To be obliged to send to Newhall or Saugus in case of an emergency, is extremely impractical. Telephone

communication is not always possible and it's a long trip to central points on the Ridge from Newhall.

We don't see any reason why people on the Ridge shouldn't have resident police protection and have it soon.
