SOLEDAD TOWNSHIP NEEDS COURT ROOM

Soledad township's justice court is one of the most important of the outside courts. Yet at this time Judge Miller has no place in which to hold court when important cases come up. He is under the necessity of "hiring a hall," or holding court under a tree, or out in the open air. Some of these fine days (and it might not be so fine) Los Angeles lawyers are going to come out here and find themselves standing out of doors while they plead their cases. And in the rainy season, something might soak into their heads. The board of supervisors seem to think that this section is so unimportant that they need no room for the township officials, yet, if our information is correct, many of the justices and constables in other townships are being furnished rooms for official business. We are informed that the revenue of the county from Judge Miller's court in the way of fines, forfeitures, etc., now amounts to over \$37,000 in the last few years. The salary list for all the officials amounts to less than ten per cent of that amount.

Supervisor Wright, in whose district this township is located, seems to be the obstruction over which the case falls down. It is stated that he claims that the judge should furnish his own court room. If that were the rule, and the salary were made adequate, there might be some reason in it. But it is not the rule and the salary is not adequate. Therefore, the supervisor, if he wishes to be fair, both to the litigating public, the court and constituents here, ought to throw his influence toward clearing up the situation.

This is not written in the interest of any official, and none have been consulted. It is only a fair statement of a situation which needs a remedy, and that soon.

COMMUNITY CHURCH ART GLASS WINDOWS

A particularly impressive feature of the new Community Presbyterian Church, now under construction, in Newhall, will be the beautiful art glass windows, to be designed and created by the Los Angeles Art Glass Company. There will be thirty-four windows in all, of several different sizes, and each one of different design, all of them in keeping with the ideals and spirit of a House of God.

Work on the windows has already been started and it is expected that they will be completed ready for installation by January first.

Maybe it is because the child labor is vital to the welfare of the families, but it is

ing selfish both on the part of greedy employers and heartless parents. Let us have the national amendment, and then laws to enforce it. Then follow up with some remedy for the sweatshop system. But every step of the way will be obstructed by selfishness from every one that profits a dollar by child labor. And that selfishness is getting in its work, right from the start.

One cannot read of the doings of rich Americans in Europe without a feeling of disgust for the

breed. Gambling and drinking, and worse things than these, dances so vile that even the French police find it necessary to break them up, in fact every sort of devilment that the corrupt mind can conceive is indulged in, without any effort toward concealment, the intent seeming to be to advertise to the world how utterly depraved Americans can be, once they try. But for the leavening influence of the great common people who believe in and practice decency and good morals, this nation would soon incur, and certainly deserve the destruction that has come upon every corrupt, rotten, immoral nation since the world began.

In the death of Gene Stratton Porter, American literature suffers an almost irreparable loss. She was a great writer in every sense of the word, and the beauty of her language made splendid setting for the pure and ennobling thoughts that seemed to glitter like diamonds in every page she wrote.

Besides her great novels "The Girl of The Limberlost," "Freckles" "Laddie," than which no better have been written in this century, she was a great authority as a naturalist, her volumes on bird life already ^{100%} classics. ~~with~~ with the great mass of stuff written by contemporaries, Mrs. Porter's writings are as pure gold to worthless rubbish. Her setting out of the things really worth while in life are, in vivid contrast to so many authors, who seem bent on tearing down the ideals that have contributed to the world's progress thru the centuries. Her class of literature is too scarce, and we wish she could have many successors.

It looks as if "It Ain't Gonna Rain No Mo," were out of date. Help make your town grow.
